
New Training & TA Programs

In 2020 SAMHSA implemented several new Training and Technical Assistance (TA) programs to support healthcare providers in all States and Territories.

This peer-led national center provides training and technical assistance related to substance use disorder recovery. The Center's strategies for training and technical assistance are organized into the following core areas of focus:



- Building and strengthening capacity of Recovery Community Organizations.
- Enhancing the professionalization of peers through workforce development.
- Providing evidence-based and practice-based toolkits and resource information to
- diverse stakeholders.



The Homeless and Housing Resource Center (HHRC) was established by SAMHSA to expand the availability of high-quality training in evidence-based housing and treatment models focused on adults, children, and families who are experiencing or at risk of homelessness and have a serious mental illness, serious emotional disturbance, substance use disorders, or co-occurring disorders.
